I am incredibly proud of the work we continue to do through the Envestnet Institute On Campus program to attract more women and racially diverse candidates to the wealth management industry. We now have 53 participating schools and continue to grow nationwide. As of June 30, 2023, over 7,100 students have completed the program, and of those students 36% are women and 31% are racially diverse. Within our outreach we continue to see more first-generation students at an average enrollment rate of 25%, and our next initiative is to expand our outreach to high school students and military Veterans of our armed forces. We are excited to welcome our newest advisory board member from the field of education, Professor Linda Lepe from the University of Wisconsin-Madison. Linda's 17 years of financial planning experience combined with her robust academic experience will help us continue our efforts of educating, mentoring, and inspiring the next generation of diverse leadership in the wealth management industry.

Partnership

It is through our partnership with the CFP Board Center for Financial Planning and the support of Envestnet that we have been able to grant 103 scholarships totaling more than **\$500,000** to date, to well deserving candidates from underrepresented populations at the professional and undergraduate school level. This spring 2023 we were able to award twentynine exceptional individuals representing five in undergraduate and twenty-four in certificate programs.

This year, Envestnet sponsored Broadridge's latest initiative to help increase the accessibility of training for women and people of color in financial professions. An initial group of 100 advisors will receive free access to Broadridge's Fi360 Accredited Investment Fiduciary (AIF) Designation Training as part of the program.

We had nine interns from the Black and Latinx (BLX) Internship Program for Financial Planners participate in our summer session, twenty-six interns from Sapere Aude Consortium, representing first-generation college students.





Making An Impact

We are pleased to present the sixth annual report for Envestnet Institute On Campus, with data ending June 30, 2023. The purpose of this report is to provide measurable results, as well as insight into the impact our program is having, from employers to our increasing diverse student population. 2015

During the first year of EIOC, 130 students completed the program.

2017

In two years, EIOC had over 1,100 students complete the program. Over 400 students joined the fall session of the program.

2019

Over 2,900 students completed the program. EIOC reached halfway point of their goal of having 5,000 students complete the program.

2021

The EIOC surpassed its goal of training 5,000 students.

2022

As ElOC continues to grow nationwide, over 6,000 students have successfully completed the program to date.

2023

We have a goal to reach 10,000 student completions by year 2025.
